### ABOUT THE ENHANCED ONCOLOGY UNIT

The Harley Street Clinic Enhanced Oncology Unit (EOU) has been developed to admit unplanned acutely unwell oncology patients and provide them with round-the-clock care. All HCA consultants can access this inpatient facility for their patients in need of acute medical or surgical care, both quickly and seamlessly.

Located on the second floor of the main hospital, the EOU is made up of 4 individual rooms for patients requiring higher levels of monitoring and intervention than those found on a routine ward, but who do not require admission to critical care. Each room is capable of offering noninvasive ventilation and cardiac telemonitoring.

Patients are cared for 24/7 by a multidisciplinary team of staff equipped with the knowledge and skill to manage acutely unwell patients and oversee safe transfer to and from a critical care area if required. The EOU ensures that oncology patients with urgent and complex needs are receiving the safest care available in an environment that can offer them the appropriate level of monitoring and support they need.

#### **OUR PATIENTS**

Patients likely to benefit from admission include, but are not limited to:

- Requiring enhanced monitoring; for example, short term invasive monitoring (CVC) to facilitate haemodynamic management/ fluid management/ electrolyte replacement.
- Requiring additional medical support; for example, correction of an acute arrhythmia, or treatment of acute pain.
- Requiring safe management of existing comorbidities.
- Management of tracheostomy patients who are acutely unwell.
- Patients with a poor prognosis and determined unsuitable for HDU/ICU admission.
- Undergoing specific surgical interventions that requiring enhanced levels of monitoring, and therapy input.
- Suspected Covid-19 infections

At The Harley Street Clinic, we pride ourselves on the quality of our multidisciplinary approach to care. The team at our EOU is no different and staff work closely to care for very vulnerable patients. Staff respond to deteriorating patients, guide management, escalate and communicate to relevant teams as well as safely ensuring the transfer of patients to and from a Critical Care area when needed.

All our oncology staff working within the EOU has had advanced training to ensure they can safely manage acutely unwell oncology patients and follow national guidelines for the management of adult patients who have a cancer diagnosis and present as an emergency or unplanned admission with a complication of their disease or cancer treatment.

Our team includes a dedicated specialist consultant, highly-qualified resident medical officers (RMOs), clinical nurse specialists and pharmacist, as well as access to therapy support and a dietician. The Harley Street Clinic and Leaders in Oncology Care (LOC) are centres of excellence for oncology and our new EOU ensures we can provide the highest-level of tailored care for acutely unwell patients. The Unit is the latest step in ensuring that we can support every oncology patient at

every stage of their journey with us.

## OUR **SAFETY** PROTOCOLS

There are many increased precautions in place for the safety of our patients and colleagues. We have a long and established history of providing complex care, which has meant the infrastructure to ensure the utmost safety for patients was largely in place before this pandemic. Nonetheless, we have reconfigured our hospital to ensure we can go above and beyond national and international safety guidelines.

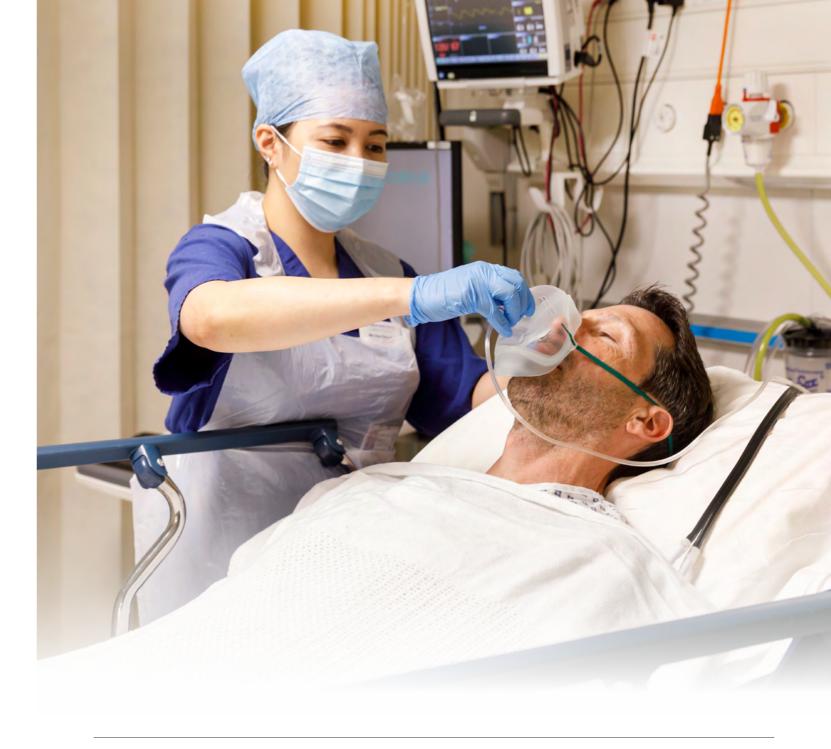
The following are a few of the many safety measures implemented within the EOU:

- We are following best practice on infection prevention including enhanced hand hygiene and dedicated hand wash stations at all entrances.
- We temperature check all patients at our hospital entrances.
- Additional PPE usage to protect patients, staff and consultants.
- A hospital wide policy conducting Covid-19 testing for staff.
- A hospital wide policy on the use of face masks for all staff, consultants and patients.
- Increased cleaning of patient rooms, waiting areas and commonly touched surfaces.

Every consultant will receive a handover email on admission and will be kept fully informed about their patient's treatment and progression.

### PRIVATE MEDICAL INSURANCE

Pre-authorisation for acute medical admissions, investigation and treatment should always be obtained from the private medical insurer. This may not always be possible in a medical emergency, and in situations where pre-authorisation from the private medical insurer has not been obtained, patients will be treated as self-pay patients and a deposit will be required by the hospital on admission.
